10. District Three Commissioner Alana Sanders - Appealing the denial of funding for the travel request submitted to attend the National Association of Black County Officials (NABCO) Conference.

Commissioner Sanders gave details of local, state and national organizations she is active and currently affiliated, acknowledging various boards she serves and the panels she has been appointed to.

Commissioner Sanders stated her appeal is to the travel and training budget that we have here in Newton County and in result to her findings, the county has nothing that states the county only supports ACCG and NACo.

Commissioner Sanders stated County Attorney Patrick Jaugstetter asked her, "did I tell you that you need to recuse yourself"? He said, did I send you an email? And I said, no sir you didn't. You're just telling me this at eight fifteen. And he said, well it's an opinion, my opinion. I am suggesting.

Commissioner Sanders stated she has an email from Patrick dated March 22nd when she asked a similar question and he stated as long as you're not receiving finances directly to you personally and benefiting you personally. I have the email from March 22nd, you do not have to recuse herself.

Motion: Commissioner Henderson motioned to approve the funding for Commissioner Sanders to go to the conference, the motion was seconded by Commissioner Sanders. Vote 2-2. Commissioner Edwards and Commissioner Mason opposed. Chairman Banes breaking tie vote in favor to deny. Motion denied.

11. Approval of Public Works to execute an agreement with Georgia 811 for the county to provide utility location services for all county owned traffic signals. An annual fee of \$200.00 is required. Services to be paid for with Public Works general funds. The new Georgia law that goes into effect January 1, 2024 classifies all counties and cities with signalized intersections as utility owners/operators. Public Works will be required to be part of the GA811 utility locate system.

The County facilities consist of four (4) traffic signals with underground cables. Public Works will be required to respond to locate requests through GA811 by locating all underground signal cables in proposed construction areas. A locate contractor will be utilized for this service.

Motion: Commissioner Edwards motioned to approve Public Works to execute an agreement with Georgia 811 for the county to provide utility services for all county owned traffic signals with a required annual fee of \$200.00, seconded by Commissioner Mason and was passed. Vote 3-0. Commissioner Henderson was not seated when the vote was taken. 9:28 p.m.

12. Approval of Public Works to contract with NOVA Engineering & Environmental, LLC to provide materials testing and inspection services for Access Road @ I-20 from West of Crowell Road and East of Harold Dobbs Road project. (PI#0015095). Cost: \$19,655.00/Funding Source: SPLOST.

Motion: Commissioner Edwards motioned to approve the NOVA Engineering & Environmental, LLC contract to provide materials testing and inspection services. Cost: \$19,655.00, seconded by Commissioner Mason and was passed unanimously. Commissioner Henderson seated @ 9:31 p.m.

13. Public Works approval to execute GDOT Construction Agreement #1 for CR511/Brown Bridge Road @ Yellow River Bridge Replacement Project. (PI#0015096)

The proposed Supplemental Construction Agreement #1 with GDOT brings the federal funding level for the project to 80%. Additional federal funding provided is \$1,258,657.91.

The county is required to match at 20%. The Supplemental Agreement with a detailed breakdown of the funding is attached.

Motion: Commissioner Edwards motioned to approve GDOT Construction Agreement #1 for CR511/Bridge Road @ Yellow River Bridge Replacement Project (PI#0015096), seconded by Commissioner Mason and was passed unanimously.

Citizen Comments

Archie Shepherd expressed opinions to the board.

Curtis Goss expressed concerns regarding the current status and the future of the Nelson Heights Community Center and asked the board to get the center back up and running. The community still wants the kids to enjoy the center.

Board Comments

Commissioner Sanders commented on a meeting that was held last week and stated she is thankful for the constituents that saw it. Commissioner Sanders also commented on the board, board meetings, made mention of debates, records and receipts, correction, corruption and confusion.

Commissioner Edwards thanked Mr. Goss for his comments and asked the County Manager to start the process to find a tenant for the Nelson Heights Community Center and work on it at his earliest convenience so the kids can receive the programming they deserve and need in that community.

There being no further business to discuss, Chairman Banes called for the meeting to adjourn. Commissioner Edwards motioned for the meeting to adjourn, seconded by Commissioner Mason and was agreed by all to adjourn.
