



STREET LIGHT RESOLUTION NO. 2031919d

A RESOLUTION PROVIDED FOR THE INSTALLATION OF STREET LIGHTS AND THE ASSESSMENT OF THE ANNUAL COSTS OF MAINTAINING AND OPERATING SAID LIGHTS AGAINST PROPERTY SERVED BY THOSE LIGHTS.

WHEREAS, Resolution #2019-031919d was adopted by the Board of Commissioners of Newton County, Georgia on the 19<sup>th</sup> day of March, 2019, providing for the establishment of street light districts in Newton County; and

WHEREAS, the required number of owners, as provided for in said resolution of the property affected by the hereinafter described Street Light District have petitioned the Board of Commissioners of Newton County, Georgia for the installation of street lights.

NOW THEREFORE, BE IT RESOLVED by the Board of Commissioners of Newton County, as governing body of said county, that there is hereby created and established within Newton County Street Light District Rosedown @ Brookside Subdivision Phase 2 for the purpose of building, erecting, establishing, maintaining, and operating street lights and lamps for the illumination of the public streets, roads, sidewalks and ways therein, as more particularly shown and delineated on the map entitled "Street Light District Rosedown @ Brookside Subdivision Phase 2 Subdivision" which map is attached hereto and made a part of this resolution by reference; and

BE IT FURTHER RESOLVED that the boundaries of said district as enumerated on said map, are hereby established as shown and delineated on said map, as full and complete as if the legal description of the courses, distances and boundaries of said district were fully set forth herein.

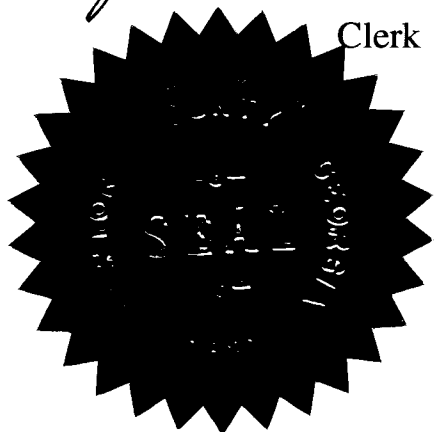
BE IT FURTHER RESOLVED that the annual cost and charges for the maintenance and operation of said street lights shall be \$4128.00 per year subject to change from time to time based on the rates and charges by the service provider (Snapping Shoals). Said annual cost and charges shall be adjusted each subsequent year by dividing the annual cost of operation by the number of units within the established Street Light District. Said costs and charges shall be a lien upon the abutting property annually from January 1<sup>st</sup> next and continuing each year until all annual charges have been paid.

IT IS ORDERED that a copy of this Resolution, together with a copy of said map, be transmitted to the Tax Commissioner of Newton County, Georgia for the collection of any and all service charges which may be imposed against any and all businesses, residences and property served by said facilities.

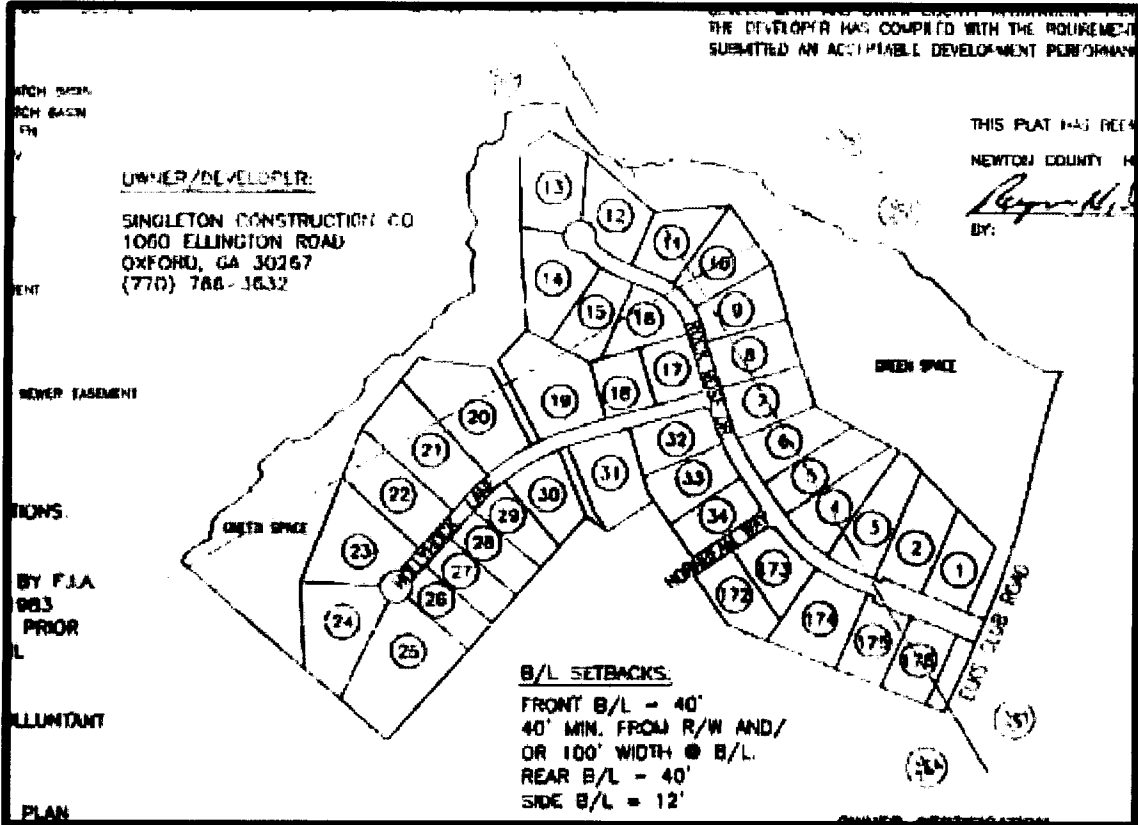

## GOVERNMENT SECURITY LIGHT CONTRACT

I, NEWTON COUNTY BOARD of COMMISSIONERS, the undersigned, being a member of Snapping Shoals Electric Membership Corporation (here-in-after called the Cooperative), do hereby request the installation of security light facilities as listed below. I understand that this service is provided under Schedule "OL" of the Cooperative's service rates as approved by the Cooperative's Board of Directors. The rates and charges indicated below reflect the current charges for these services under the current rate schedule and are subject to change from time to time, including during the initial term of this contract. Further, this service is subject to the following terms and conditions:

1. Service will be rendered only at locations that, solely in the opinion of the Cooperative, are readily accessible for installation and maintenance.
2. Service includes normal maintenance (fixture, lamp, photocell, pole, wire) and energy usage of fixture. Members may be required to reimburse the Cooperative for damages caused by vandalism.
3. Wood pole height at discretion of SSEM engineers.
4. Payments required herein do not constitute ownership of any facilities by the member. The Cooperative retains full ownership of lights, poles, wiring, etc.
5. Tenants requesting Security Light service must acknowledge their rights and obligations under this agreement as the Responsible Party and obtain signature of property owner below.

**STREET LIGHT PETITION PROCESS (Revised 1-26-16)**

---

Pursuant to Chapter 4, Article I, Section 4-109 of the Newton County Code of Ordinances (Division II), to have street lights installed in the unincorporated area of Newton County a petition must be signed by the property owners of at least fifty-one percent (51%) of the total lots within a designated Street Light District.

The first step in the process is for one or more residents of the proposed Street Light District to submit a request to the Department of Development Services (and pay any applicable administrative fee). The Department will establish a list of property owners within the proposed Street Light District according to the current Tax Records as maintained by the Tax Assessors Department. This list will be used to create a petition for the applicants to use in collecting signatures (the County-issued petition form must be used, substitutes will not be accepted).

After the applicants collect signatures, the form should be returned to the Development Services Department, at which time it will be verified as to whether or not a sufficient number of signatures have been obtained. A properly submitted petition will be forwarded to the Newton County Board of Commissioners for consideration at the next available meeting. The instillation of street lights usually takes from six to eight weeks after the petition is approved by the Board of Commissioners.

If approved by the Board of Commissioners, the County will bill all the residents within the Street Light District based on the number of lots owned. This annual bill will be included with the regular County taxes and will be paid in the same manner at the Tax Commissioners office in the Newton County Administrative Building.

The base rate which will be charged to each lot shall be administered in the same manner as property taxes through the Newton County Tax Assessors Department. The annual charge is necessary to pay the costs for operating and maintaining the lighting to meet the requirements of the District. All property, developed or undeveloped, commercial or residential, which is within the Street Light District will be charged the base rate.

The locations for placement of the poles and lights will be determined by personnel of this office working with personnel of the power company. The lights will have automatic photoelectric controls that turn them on at dusk and off at dawn. Underground wiring will be used on streets that are now served by underground electric distribution systems (otherwise, overhead wiring will be used).










